## HERE ARE JUST SOME OF THE WAYS YOUR DONATIONS HELP

### **Activities for Evergreen Adult Day Services Participants**

Donations to the Evergreen Adult Day Services Fund help to provide music equipment, craft and art supplies and baking needs for the program's participants, helping them to remain active and engaged during their time at Evergreen. In addition, funds help to pay for entertainment, special activities and outings.

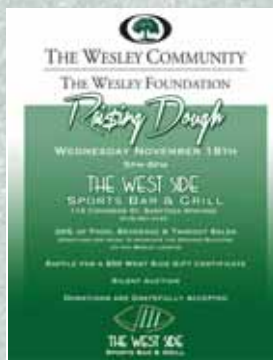


### **2nd Annual Balloon Walk and BBQ: Day of Fun and Food Supports Wesley**

In addition, the development of therapeutic activity stations for residents with dementia provides activities that are specific to an individual's level of functionality and interests.
