Special Activities for Wesley Health Care Center Residents

The With a Heart Choose a Friend Fund provides for trips and activities that enhance the quality of life of our Wesley Health Care Center long-term care residents. These activities include lunches, dinners, museum visits and outings to Saratoga Race Course.

Pets

Donations to the Project Homecoming Fund help to provide supplies and veterinary care for our beloved pets at Wesley Health Care Center. Contact with these pets comforts our long-term care residents and brings smiles to their faces.

Special Events for Independent Housing Residents

In 2016, these funds provided over 260 co-pays to help cover the costs of quality physical therapy visits here at Wesley.

Grants

The Wesley Community is grateful for the generosity of the many foundations, trusts and charitable funds whose grants have enabled us to provide an increased number of enjoyable activities, some new and improved equipment, and more cost effective services to our residents. We thank these fine groups for their support!



Dominic Ferraioli Foundation - \$7,680

Wesley Health Care Center has expanded its existing inpatient rehabilitation services offerings through the addition of a body weight supported treadmill training system. The new equipment will allow residents of all abilities to engage in higher-level balance activities in safe and controlled ways. The new equipment was funded, in part, by a \$7,680 grant from the Dominic Ferraioli Foundation.



William Gundry Broughton Charitable Private Foundation - \$7,500

One hundred percent of this grant helps support the cost of programs for the resident activities program at Wesley Health Care Center. Funds help pay for some of the on-site activities each year that feature professional entertainers, and other types of in-house activities include crafts and baking. The funds also help pay for some of the community-based trips and activities planned each year, including admission fees for residents who could not otherwise pursue these rewarding activities.

Arnold Cogswell Health Care Fund of the Community Foundation for the Greater Capital Region - \$14,124

The \$14,124 grant from the Arnold Cogswell Health Care Fund of the Community Foundation for the Greater Capital Region was used to purchase and update medical equipment for Wesley Health Care Center's nursing department, including three electrocardiogram (EKG) machines, two mechanical insufflation-exsufflation machines (cough assist devices), and an automated external defibrillator (AED).

Alfred Z. Solomon Charitable Trust - \$9,000

The Digital Communications Project funded by the Alfred Z. Solomon Charitable Trust will provide residents of The Wesley Community access to custom programming through their existing television sets via dedicated channels, further connecting them with activities, entertainment, and information. Custom channels will be developed for The Wesley Community's residential entities: Embury Apartments, Wesley Health Care Center and Woodlawn Commons. Wesley will live-stream some on-campus activities, programs, and events to those who lack the ability to attend such offerings in-person, or when space is limited for in-house events. In addition, live-streaming and recording/rebroadcast of popular musicians, lecturers, and performers will be shared across each section of the campus, as relevant. The project also creates digital information hubs for residents' guests and families through the addition of three digital display screens at the main entrances to the Wesley Health Care Center.

Adirondack Trust Company Community Fund - \$1,320

These funds helped Wesley Health Care Center purchase two PT/INR Control Clinical Monitoring Machines. An anticoagulant often prescribed for heart patients at Wesley Health Care Center can interact with other medications and some foods. To ensure the drug remains at effective therapeutic levels, blood draws for residents may be required daily, every other day, or weekly. These new monitoring devices use the finger stick method, which is less invasive and more comfortable for our residents, and give results in minutes instead of hours so that treatment can begin sooner. Additionally, the cost per test is much lower.



Marjorie Rockwell Fund for the Disabled of the Community Foundation for the Greater Capital Region - \$6,000

A \$6,000 grant from The Marjorie Rockwell Fund for the Disabled of The Community Foundation for the Greater Capital Region helped purchase a portable sound system to improve sound quality of musical programs and lectures at Wesley Health Care Center. In addition, a grill and gardening planters expanded the outdoor opportunities for residents. Additional kitchen equipment offered residents expanded opportunities for baking with assistance from staff. The grant also allowed Wesley to expand the number of trips and activities for long-term care residents for the year.

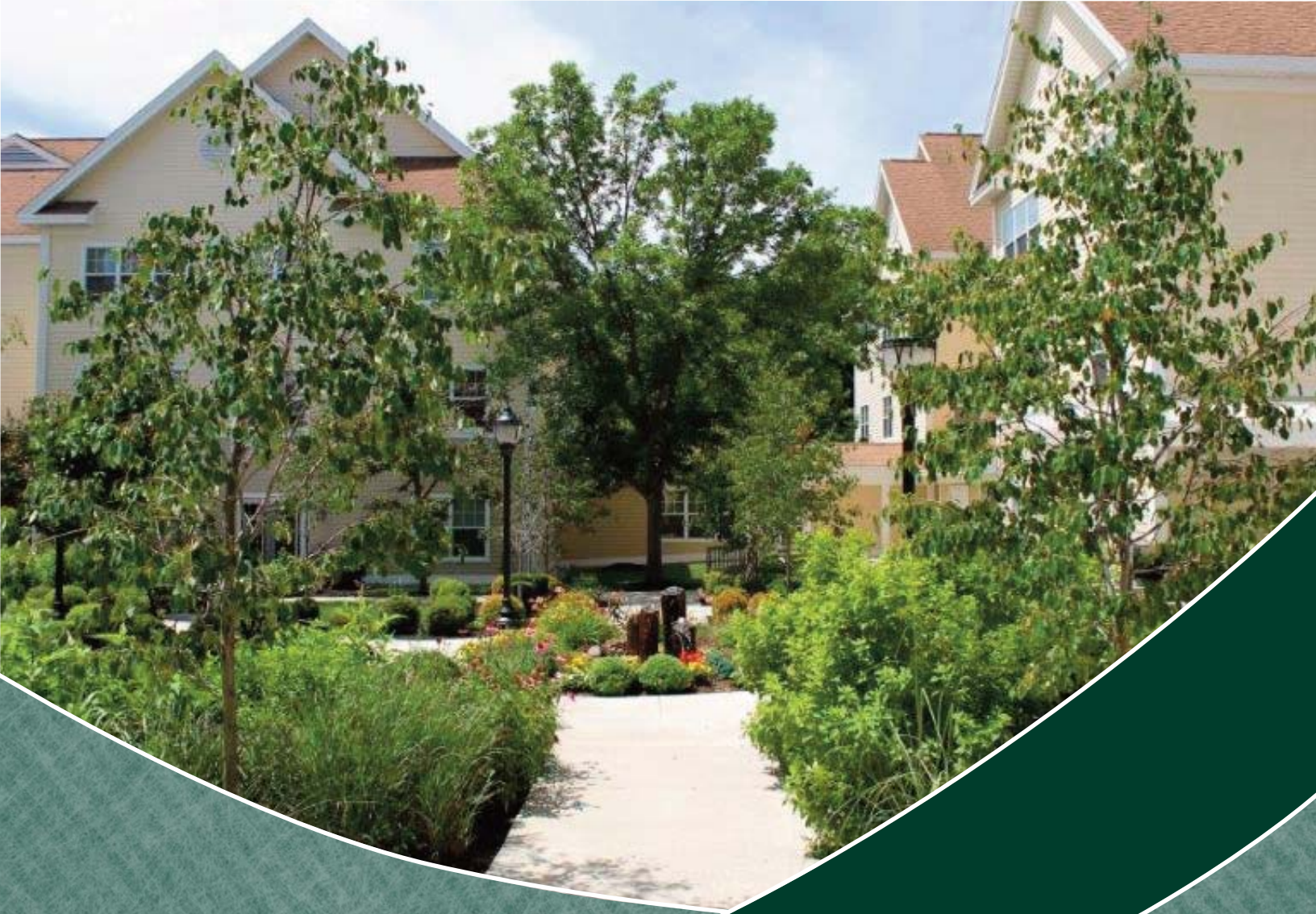
